

**TERMS AND CONDITIONS FOR**  
**KRIS+ 30% JANUARY MILES-BACK PROMOTION**

These terms and conditions govern the Kris+ 30% January miles-back promotion (the “**Promotion**”) organised by Singapore Airlines Limited (“**SIA**”). This Promotion will be carried out on the Kris+ mobile application (“**Kris+ App**”).

1. The Promotion is applicable to all KrisFlyer members who have performed a Kris+ Redemption Transaction during the Promotional Period (as defined in paragraph 2) (“**Participant**”). For the purposes of these terms and conditions, a “**Kris+ Redemption Transaction**” means any single transfer of at least SGD0.10 or 15 KrisPay miles made to any Kris+ partner in Singapore by a Participant using KrisPay miles on the Kris+ App, regardless of the type of mobile device from which such redemption transaction is performed, within the Promotional Period (as defined in paragraph 2).
2. The Promotion commences on 13 Jan 2021, 0900 hrs (Singapore time) and ends on 24 Jan 2021, 2359 hrs (Singapore time) (“**Promotional Period**”).
3. Participants will receive KrisPay miles back based on the percentage of the actual number of KrisPay miles transferred as follows:

<b>KrisPay miles Transferred to Kris+ Partner</b>	<b>Miles-Back (%)</b>
15 miles (SGD 0.10) and above	30% of the KrisPay Miles transferred to the Kris+ Participant (rounded down to the nearest whole number)

4. After each qualifying Kris+ Redemption Transaction has been completed, the resulting KrisPay miles back will be credited into the Participant’s Kris+ account instantly. Such KrisPay miles shall be valid for 6 months from the date of credit.
5. Kris+ Partners reserve the right to reject any splitting of the KrisPay miles transferred to them. A single receipt qualifies Participant to make one(1) transfer of KrisPay miles to Kris+ Partner.
6. KrisPay miles credited into the Participant’s KrisPay account can only be used within the Kris+ App and cannot be transferred into any KrisFlyer account. KrisPay miles are also non-transferable to other Kris+ accounts and cannot be exchanged for cash.
7. By participating in the Promotion, each Participant:
  - a. agrees to comply with and be bound by these terms and conditions, SIA’s conditions of use of website, SIA’s Privacy Policy, KrisFlyer Terms and Conditions, and the Kris+ Terms and Conditions (collectively, “**SIA Terms & Conditions**”) and
  - b. agrees that any and all personal data he/she submits (including his/her KrisFlyer membership number) may be collected, used, disclosed, or otherwise

processed (collectively, “**Processed**”) by SIA for the purposes of organizing the Promotion. All collection, use and disclosure of each Participant’s personal data will be in accordance with SIA’s Privacy Policy available at [https://www.singaporeair.com/en\\_UK/privacy-policy/](https://www.singaporeair.com/en_UK/privacy-policy/).

8. Non-compliance with or breach of these SIA Terms & Conditions may result in the Participant being disqualified at any stage of the Promotion, and any prizes won may be forfeited, withheld, withdrawn or reclaimed.
9. All decisions made by SIA, in respect to any matter relating to this Promotion shall be final. SIA reserves the right to vary these terms and conditions, amend the list of Kris+ Partners in which eligible Kris+ Redemption Transactions may be made, terminate or otherwise amend this Promotion without prior notice, at its sole and absolute discretion.
10. SIA reserves the right to verify the eligibility of Participants.
11. To the extent permitted under applicable law, SIA will not be responsible or liable for any consequences that any participant may suffer (including without limitation any damage, loss, injury or disappointment) by participating in the Promotion or the participant’s acceptance of any prize.
12. These terms and conditions shall be governed by and construed in accordance with the laws of the Republic of Singapore and shall be subject to the exclusive jurisdiction of the Singapore courts.
